## <u>ORDER</u>

Date: 30-03-2020

In partial modification of the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department Order No.2035/ R&DM(DM) dated 27.3.2020, the State Government do hereby make the following amendments to the said order, namely:-

- 1. In clause 3, after sub-clause (i) of the Exceptions, the following sub-clauses shall be added.
  - "(j) Agencies engaged in procurement of agriculture products, including MSP operations.
  - (k) 'Mandis' operated by the Agriculture Produce Market Committee or such other authority as notified by the State Government.
  - (I) Any other department or office or organisation as decided by the Government."
- 2. In clause 5 -
  - in sub-clause (a) of the Exceptions, after the word "seeds", comma and the word "fertilizers" shall be inserted.
  - ii. After sub-clause (m), the following sub-clauses shall be added.
    - "(n) Farming operations by farmers and farm workers in the field.
    - (o) Custom Hiring Centers (CHC) related to farm machinery."
- 3. In clause 6, after sub-clause (f) of the Exceptions, the following sub-clause shall be added.
  - "(g) Manufacturing and packaging units of fertilizers, pesticides and seeds."
- 4. In clause 7, after sub-clause (f) of the Exceptions, the following sub-clause shall be added.
  - "(g) Intra and inter-sate movement of harvesting and sowing related machines like combined harvester and other agriculture/ horticulture implements."
- 5. After clause 27, the following clause shall be added.
  - (27) The Chief Secretary of the State is authorized to make any further addition or alteration to the Order No.2035/R&DM(DM) dated 27.3.2020 as and when necessary.
