THE LOW PRESSURE AREA OVER NORTH COASTAL ODISHA AND NEIGHBOURHOOD NOW LIES OVER NORTH COASTAL ODISHA & ADJOINING GANGETIC WEST BENGAL. ASSOCIATED CYCLONIC CIRCULATION NOW EXTENDS UPTO 7.6 KM ABOVE MEAN SEA LEVEL TILTING SOUTH-WESTWARDS WITH HEIGHT. IT IS VERY LIKELY TO BECOME MORE MARKED DURING NEXT 24 HOURS (.)

UNDER THE INFLUENCE OF LOW PRESSURE AREA OVER NORTH COASTAL ODISHA AND ADJOINING GANGETIC-WEST BENGAL, SQUALLY WEATHER WITH SURFACE WIND SPEED REACHING 45-55 KMPH VERY LIKELY OVER ALONG & OFF ODISHA COAST, NORTH BAY OF BENGAL AND WEST CENTRAL BAY OF BENGAL (.) FISHERMEN ARE ADVISED NOT TO VENTURE INTO SEA ALONG AND OFF ODISHA COAST TILL 16TH AUGUST2020 (.)
