A LOW PRESSURE AREA FORMED OVER NORTH BAY OF BENGAL AND NEIGHBOURHOOD AND ENHANCED RAINFALL ACTIVITY OVER ODISHA (.)

1. **AS PER THE SPECIAL BULLETIN-2 ISSUED BY IMD TODAY (DT.24.8.2020)**, UNDER INFLUENCE OF YESTERDAY'S CYCLONIC CIRCULATION OVER BANGLADESH AND NEIGHBOURHOOD, A LOW PRESSURE AREA HAS FORMED OVER NORTH BAY OF BENGAL AND NEIGHBOURHOOD AND THE ASSOCIATED CYCLONIC CIRCULATION EXTENDS UPTO 7.6 KM ABOVE MEAN SEA LEVEL TILTING SOUTHWESTWARD WITH HEIGHT. IT IS LIKELY TO BECOME MORE MARKED DURING NEXT 2 DAYS (.)

2. **WEATHER FORECAST AND WARNING:** SQUALLY WEATHER WIND SPEED REACHING 45-55 KMPH VERY LIKELY OVER NORTH BAY OF BENGAL AND ALONG & OFF ODISHA COAST DURING 25TH TO 27TH AUGUST, 2020 (.)

**DAY 1** (VALID UP TO 0830 HRS IST OF 25.08.2020).

**ORANGE WARNING :** HEAVY TO VERY HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF BALASORE, BHADRAK, JAJPUR, KENDRAPADA, MAYURBHANJ, AND KEONJHAR (.)

**YELLOW WARNING:** HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF JAGATSINGHPUR, CUTTACK, DHENKANAL, PURI, SUNDARGARH, AND DEOGARH (.)

**DAY 2** (VALID FROM 0830 HRS IST OF 25.08.2020 UP TO 0830 HRS IST OF 26.08.2020) :

**RED WARNING :** HEAVY TO VERY HEAVY RAINFALL VERY LIKELY TO OCCUR AT A FEW PLACES WITH EXTREMELY HEAVY RAINFALL AT ISOLATED PLACES OVER THE DISTRICTS OF BALASORE, BHADRAK, JAJPUR, KENDRAPADA, JAGATSINGHPUR, CUTTACK, KEONJHAR, MAYURBHANJ, DHENKANAL, ANGUL, AND DEOGARH (.)

**ORANGE WARNING :** HEAVY TO VERY HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF PURI, KHURDHA, SUNDARGARH, SAMBALPUR, SONEPUR, BOUDH, BOLANGIR AND KANDHAMAL (.)



**YELLOW WARNING:** HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF JHARSUGUDA, BARGARH, KALAHANDI, NAYAGARH, GANJAM, NUAPADA, NAWARANGPUR, MALKANGIRI AND KORAPUT (.)

**DAY 3** (VALID FROM 0830 HRS IST OF 26.08.2020 UP TO 0830 HRS IST OF 27.08.2020)

**RED WARNING :** HEAVY TO VERY HEAVY RAINFALL WITH EXTREMELY HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF SAMBALPUR, SONEPUR, BARGARH, BOUDH, BOLANGIR, KALAHANDI, KANDHAMAL, NUAPADA, AND DEOGARH (.)

**ORANGE WARNING :** HEAVY TO VERY HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF JHARSUGUDA, SUNDARGARH, NAWARANGPUR, KANDHAMAL, ANGUL, AND KEONJHAR (.)

**YELLOW WARNING:** HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF DHENKANAL, MAYURBHANJ, BALASORE, MALKANGIRI, KORAPUT AND JAJPUR (.)

**DAY 4** (VALID FROM 0830 HRS IST OF 27.08.2020 UP TO 0830 HRS IST OF 28.08.2020)

**YELLOW WARNING:** HEAVY RAINFALL VERY LIKELY TO OCCUR AT ISOLATED PLACES OVER THE DISTRICTS OF BARGARH, NUAPADA, BOLANGIR, JHARSUGUDA, SAMBALPUR, SUNDARGARH, AND KEONJHAR (.)

**DAY 5** (VALID FROM 0830 HRS IST OF 27.08.2020 UP TO 0830 HRS IST OF 28.08.2020) : **NIL**

3. **WEATHER WARNING FOR FISHERMEN OF ODISHA COAST:** FISHERMEN ARE ADVISED NOT TO VENTURE INTO SEEA LONG AND OFF ODISHA COAST DURING 25TH TO 27TH AUGUST 2020. WHOEVER IN DEEP SEA AREA, ARE ADVISED TO RETURN TO COAST BY TODAY NIGHT (.)

ENSURE FUNCTIONING OF CONTROL ROOM ROUND THE CLOCK (.) RAINFALL MAY BE REPORTED IMMEDIATELY TO THIS OFFICE (.) SITUATION REPORT MAY BE FURNISHED (.)
