1) Start of obtaining tender document - "23.05.2023, 11.00 AM".

Last date for receipt of bid document online – "27.06.2023, 5.30 PM"

3) Date for Opening of Technical Bids - "28.06.2023, 11.00 AM"

SI. No.2 of the terms and conditions of Tender for supply of PE Black Polythene Film/ Sheet at Annexure-A (Page No.4) of the e-Procurement Notice No.2658/ R&DM(DM) dt.22.05.2023 may be read as follows.

"Obtaining/ downloading of Tender form for the purchase of Polyethylene (PE) Black film/ Sheet will start from 23.05.2023 from 11.00 AM and will end on 27.06.2023 by 5.30 PM. Submission of Tender form will close on 27.06.2023 by 5.30 PM. The opening of Technical bid will be on 28.06.2023 at 11.00 AM and opening of financial bid of the successful tender will be informed to the bidders later. The rates quoted shall be inclusive of GST or any taxes/ cess etc. & FoR destinations anywhere in Odisha. In case of any changes in GST Rate, the new Tax rate will be applicable as per Law".

D) The following terms & conditions are hereby added to Annexure-C (Eligibility Criteria at Page No.10) as SI.No.5 to SI.No.10 of e-Procurement Notice No.2658/ R&DM(DM) dt.22.05.2023.

SI.No.5 of Annexure-C "The minimum average annual financial turnover of the Manufacturer of the offered product during the last three years, ending on 31st March of the previous financial year, should be Rs.3.00 crore. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chattered Accountant/ Cost Accountant indicating the turn over details for the relevant period shall be uploaded with the bid. In case the date of constitution/ incorporation of the Manufacturer is less than 3 year old, the average turnover in respect of the completed financial year after the date of constitution shall be taken into account for this criteria".

SI.No.6 of Annexure-C "The bidder must have manufacturing capacity of 200 MT per month".

SI.No.7 of Annexure-C "The bidder must have valid consent letter from the State Pollution Control Board certification for the tendered item".

SI.No.8 of Annexure-C "The bidder is required to produce designated raw material purchase bill as per BIS (all inputs) at the time of inspection, the same should not be more than 3 months old".

SI.No.9 of Annexure-C "The bidder must have full-fledged in-house laboratory to test all necessary parameters as per BIS. All the equipment should be certified and calibrated by NABL(National Accreditation Board for Testing and Calibration Laboratories) Agencies".

SI.No.10 of Annexure-C "The purchaser can visit the bidder facility at any time before finalisation of order at any given time and without intimating him along with third party inspection agency".

All other terms and conditions shall remain unchanged.
