ORDER

In partial modification of the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department Order No.2035/ R&DM(DM) dated 27.3.2020, the State Government do hereby make the following amendments to the said order, namely:-

1. In clause 3, after sub-clause (i) of the Exceptions, the following sub-clauses shall be added.
“(j) Agencies engaged in procurement of agriculture products, including MSP operations.
(k) ‘Mandis’ operated by the Agriculture Produce Market Committee or such other authority as notified by the State Government.
(l) Any other department or office or organisation as decided by the Government.”
2. In clause 5 -
 - i. in sub-clause (a) of the Exceptions, after the word “seeds”, comma and the word “fertilizers” shall be inserted.
 - ii. After sub-clause (m), the following sub-clauses shall be added.
“(n) Farming operations by farmers and farm workers in the field.
(o) Custom Hiring Centers (CHC) related to farm machinery.”
3. In clause 6, after sub-clause (f) of the Exceptions, the following sub-clause shall be added.
“(g) Manufacturing and packaging units of fertilizers, pesticides and seeds.”
4. In clause 7, after sub-clause (f) of the Exceptions, the following sub-clause shall be added.
“(g) Intra and inter-sate movement of harvesting and sowing related machines like combined harvester and other agriculture/ horticulture implements.”
5. After clause 27, the following clause shall be added.
(27) The Chief Secretary of the State is authorized to make any further addition or alteration to the Order No.2035/R&DM(DM) dated 27.3.2020 as and when necessary.






