***Sub: Strict measures to ensure social distancing.***


Madam/ Sir,

As you know many activities will start from 20<sup>th</sup> April in different sectors, there is a need for concerned departments at the district level to develop SoPs for maintaining social distancing, personal hygiene and for following other guidelines and advisories of Health & Family Welfare Department for COVID-19. Necessary arrangements may be made to make workers and staff aware about Dos and Don'ts and ensuring safety at worksites and in offices.

Disturbing pictures of large congregations of people have come to the notice of the Government in front of several bank branches where people are assembling for withdrawal of money from their Jan Dhan Accounts. No social distancing is maintained.

Therefore, it is requested to look into this matter and make arrangements for orderly withdrawal by strictly following social distancing norms. There should not be any compromise on social distancing. Please talk to bank authorities and if required some officers and police personnel may be deployed to control the crowd. Banks may be asked to put some shade (samiana) in front of Bank branches as temperature has shot up.
