ORDER

WHEREAS, with a view to ensuring strict social distancing and isolation to contain the spread of COVID-19 pandemic, the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department, vide Orders No.2214/R&DM(DM) dated 17th April, 2020, has extended the lockdown in the entire State of Odisha until Midnight of 3rd May, 2020;


AND WHEREAS, in view of the summer season, it is felt necessary to reschedule the working hours of all Banks operating in the State to morning hours in the interest of the customers;

AND WHEREAS, opening of the banks in early hours is likely to avoid heavy rush in bank premises ensuring proper social distancing;

AND WHEREAS, all State Government offices in the State except at Cuttack, Puri, Chhatrapur, Berhampur, Koraput and Bhubaneswar are functioning in morning hours i.e., from 7 AM to 1 PM from 10th April to 15th of June;

NOW THEREFORE, in exercise of the powers conferred under section 22(2)(h) of the Disaster Management Act, 2005, the State Executive Committee do hereby order that all the Banks operating in the State of Odisha except those in the limits of Cuttack, Puri, Chhatrapur, Berhampur, Koraput and Bhubaneswar cities/ towns shall function from 8.00 AM to 2.00 PM with customer service hours from 8.00 AM to 01.00 PM till the lockdown period is over. The norms of social distancing communicated vide Order No.2214/R&DM(DM) dated 17th April, 2020 shall be strictly followed by all banks.




